Foreign Tourist (FT) Quota Ticket Booking

General Terms and Condition

- Ticket can be booked by the Foreign Tourist well in advance i.e upto 365 days through internet (e-ticket).
- Allowed to book the accommodation in Executive Class(EC)/1st AC/2nd AC/3rd AC/CC/SL/2S Class in all the trains (FT Booking not allowed in Suvidha train) including Shatabdi, Rajdhani, Durontno, Gatimaan, etc. For which fare shall be uniformly charged at 1.5 times of normal fare by Indian Railways.
- IRCTC Enhanced Service Charge for ticket booking in FT quota is Rs. 200 + Service Tax as applicable, per ticket.
- Payment shall be made only through International Debit/Credit cards.
- For booking the ticket the Passport number & Nationality of the passenger has to be mandatorily entered for generation of the ticket.
- An SMS confirming the reservation of the ticket will be sent to the registered mobile number of users.
- The passenger who has reserved the ticket under FT quota has to carry the original Passport (given at the time of ticket) with valid Visa as identity proof and make it available during journey. In case the passenger is not able to show the original passport with valid visa, the passenger shall be treated as without ticket and charged penalty equivalent to 3 times the fare of ticket and if passengers fail to pay the penalty, legal action will taken against the passenger. All passengers booked on a ticket are required to carry their original passport & Visa separately.
- In case of cancellation of tickets booked under FT quota by the passenger flat 50% of the fare shall be deducted in addition to the cancellation charges as applicable while refunding the amount. Time limit for granting 50% refund shall be as per extant rules i.e upto 4 hours before scheduled departure of train, through website only.
- The berth under existing Foreign Tourist Quota (FT) shall be booked on 1.5 times of the normal fare.
- For child travelling without berth, fare will be charged as per rules i.e. half of the adult base fare which in case of FT will be equal to 1.5 times of the normal base fare.
- Cancellation rules for WL and RAC tickets issued under FT quota will remain same as GN Quota rules. Cancellation charges for WL/RAC will remain same as that of General Waitlist passengers as accommodation is not provided.
- For the ticket booked beyond Advance Reservation Period (ARP), berth shall be allotted on opening of ARP.
- No concession is allowed in FT Quota ticketing booking.
- No change of name shall be permissible on FT quota ticket under any circumstances.
- Agents are not allowed to book tickets under FT quota.
- I-ticket booking is not allowed under FT quota.
- Boarding point change is allowed only within ARP period ie. after allocation of seat/berth.
- ERS printing is allowed only within ARP period i.e after allocation of seat berth.
- Travel insurance is not allowed for FT quota booking.
- VIKALP facility not allowed for FT quota booking.
